NOTE:

- (1) The Competitions organized by the Universities, Institutes, reputed Law firms, Bar Associations, either individually or collectively by any one or more of them alone shall be considered for the purpose of evaluation.

- (2) Provided that, the Competitions conducted by any other Organizations or entities including the results of semi-finals of the competitions organized by the entities enumerated in (1), or Academic Performance could be taken into account solely for the purpose of breaking a tie in the points between two students who have applied for the same post.

Students who are already holding any position/office in any other committee of SOEL are ineligible to apply.

It is also informed that students irrespective of the year or course of study can apply for the posts of MCA's **official photographers** of which 4 students would be selected.

Interested students must submit through e-mail:

1. An **Application Letter** specifying the post for which the application is being submitted and the interest in being appointed to such post;
2. **Curriculum Vitae / Resume** containing:
 - a. List of all relevant competitions participated and the result of such participation
 - b. Previous experience as an MCA Member (if any); and
3. **Copy of all relevant Certificates** for the relevant competitions listed in 2.(a).

The E-mails carrying such requests shall indicate "Application for the MCA 2021-2022" as the subject of the email. The E-mail in the prescribed format must be sent to facultymcasoel.2021@gmail.com on or before 17.30 hours on the 18th of August (Wednesday), 2021. Applications sent to any other e-mail ID shall not be considered.
